### SUPPLEMENTAL BID BULLETIN NO. 1

This Supplemental Bid Bulletin (SBB) No. 1 is issued to amend certain provisions in the Bidding Documents dated 03 October 2018 for the Package Sale of Unserviceable Assets of Sold Plants and Other Disposable Assets at BacMan-Ormat in Manito, Albay, Ligao Stockyard in Ligao, Albay, and Tiwi Geothermal Power Plant and Philippine Geothermal Production Corporation (PGPC) in Tiwi, Albay.

The following clauses are hereby amended as follows:

d. Clause 21.5, Section II. ITB	Immediately after the BAC-Disposal has notified the first Bidder of its post-disqualification, and notwithstanding any pending request for reconsideration thereof, the BAC-Disposal shall initiate and complete the same post-qualification process on the Bidder with the second highest bid. If the second Bidder fails during post qualification, the 2 <sup>nd</sup> ranking bidder will be notified, and the next process will proceed with the 3 <sup>rd</sup> ranking bidder. If the 3 <sup>rd</sup> ranking bidder fails during post qualification, 3 <sup>rd</sup> ranking bidder will be notified, and the BAC-Disposal will declare failure of bidding after all request for consideration, if any, have been resolved.	Immediately after the BAC-Disposal has notified the first <b>Highest Bidder</b> of its post-disqualification, and notwithstanding any pending request for reconsideration thereof, the BAC-Disposal shall initiate and complete the same post-qualification process on the Bidder with the second highest bid. If the second <b>Highest Bidder</b> fails, the <b>procedure</b> for post-qualification shall be for the Bidder with the next highest bid, and so on until the <b>Highest Responsive Bid</b> is determined for an award.

Accordingly, Site Visit Request Form (Form No. 6) is hereby modified, as attached.

All relevant provisions of the bidding documents affected by the above amendments are hereby modified accordingly.
