1. NOTICE TO BIDDERS

Bidders are hereby notified of the amendments, revisions, modifications and clarifications to the Bidding Procedures dated 05 October 2018 for the Sale of the 650 MW Malaya Thermal Power Plant located in Barangay Malaya, Pililla, Rizal.

In accordance with the Bidding Procedures, Bidders are required to acknowledge receipt and acceptance of the terms and conditions of the Bidding Procedures and each Supplemental Bid Bulletin on the space provided in the Letter of Transmittal accompanying this Supplemental Bid Bulletin.

Failure to acknowledge receipt and acceptance of the terms and conditions of the Bidding Procedures and each Supplemental Bid Bulletin may cause the Bid to be considered as not responsive to the Bidding Procedures, which could result in the disqualification and/or rejection of the Bid.

In any case, it is conclusively presumed that the Bidder in preparing the Bid has taken into account the information and procedures set forth herein in the Bidding Procedures and in the subsequent Supplemental Bid Bulletins.

2. CHANGE OF CONDITION OF THE MALAYA THERMAL POWER PLANT (MTPP)

The Privatization, Bids and Awards Committee (PBAC) hereby informs all Qualified Bidders on the change of condition of MTPP, as follows:

Plant	Rated Capacity, MW	Dependable Capacity, MW
Unit 1	300	150
Unit 2	350	0

Unit 1's rated capacity is temporarily curtailed due to tube leak in the two (2) units of High Pressure Heater, which requires replacement. The High-Pressure Turbine, Generator and other auxiliary equipment of Unit 1 were overhauled and completed in August 2015 while the turbine generator and other major auxiliary equipment of Unit 2 is due for preventive maintenance schedule.

Unit 2	350	130

MTPP Unit 1 was declared unavailable on 03 May 2019 due to damaged Low Pressure (LP) turbine as a result of equipment failure of the National Grid Corporation of the Philippines' (NGCP) Power Circuit Breakers.


MTPP Unit 2 was declared available on 22 June 2019 to support the Luzon Grid with dependable capacity of 130MW. Unit 2 is running with deteriorated Air Preheater Heating Elements.

3. **MISCELLANEOUS PROVISIONS**

- a. Unless inconsistent with the provisions of this Supplemental Bid Bulletin No. 8, the provisions of the Bidding Procedures remain effective and binding to the Bidders.
- b. If any one or more of the provisions of the Bidding Procedures or Supplemental Bid Bulletin Nos. 1, 2, 3, 4, 5, 6, 7 and 8 (collectively, the "Procedural Documents") is held to be invalid, illegal or unenforceable, the validity, legality or enforceability of the remaining provisions of each and all Procedural Documents will not be affected thereby. To the extent permitted by Philippine Law, each Bidder waives any provision of law which renders any provision of any of the Procedural Documents invalid, illegal or unenforceable in any respect.
